One \$1,000 scholarship will be awarded to a Collegiate Farm Bureau member.

SUPPORTING MATERIALS

Applicants must provide the following materials along with the scholarship application:

- A copy of the applicant's résumé.
- Two essays (500 words maximum for each essay), double spaced, typed in Times New Roman, 12-point font.
 - How can Farm Bureau get collegiate members more involved?
 - Explain your preferred career and why you have chosen it.
